

ART DROP OFF:

PLEASE DO NOT UNLOAD YOUR ART FROM YOUR CAR UNTIL YOU HAVE FIRST PARKED AND **PICKED UP YOUR ENTRY PACKET** AT THE COMPETITIVE EXHIBITS OFFICE. YOU MAY THEN DRIVE INSIDE THE GATE AND UNLOAD AT THE DESIGNATED ART DROP-OFF SITE.

- a. **DROP OFF:** Don't waste your time standing in line if your art is not framed or wired properly. The peak waiting time is from 3-6 pm on the first day of Entries Received (see Schedule of Events above)
- b. **PICK UP:** PLEASE ENTER AT DOOR MARKED "**FINE ARTS**" ONLY. Fine Arts must be picked up on Artwork Release Monday (see Schedule of Events) between 2-7 PM. The San Mateo County Fair assumes no responsibility for items that are not picked up on the release day. In order to ensure an orderly process and guarantee the safety of your art, exhibitors are required to wait for an attendant to retrieve their work from the display wall. Your understanding and patience is greatly appreciated.

FAIR MANAGEMENT SHALL NOT BE RESPONSIBLE FOR LOSSES OR DAMAGES INCURRED FROM ACCIDENTS OR VANDALISM BY ANY OF THE EXHIBITORS OR EXHIBITS AND THE EXHIBITORS SHALL HOLD HARMLESS AND INDEMNIFY THE FAIR AGAINST ANY LEGAL PROCEEDINGS ARISING FROM SUCH ACCIDENT OR LOSS. THIS INCLUDES GLASS FROM FRAMED ARTWORK.

Section III SUBMISSION RULES



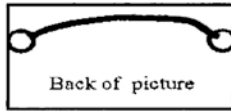
IN ORDER TO ENSURE THE QUALITY OF OUR SHOW, WE WILL ONLY ACCEPT WORK THAT HAS BEEN PRODUCED IN THE LAST THREE YEARS. PREVIOUSLY ENTERED ARTWORK IS ALSO NOT ELIGIBLE FOR JUDGING OR AWARDS. POORLY GLASSED OR FRAMED ART WILL NOT BE DISPLAYED IF DEEMED UNSAFE. WORK COPIED FROM OTHER ARTISTS OR FROM PUBLISHED BOOKS IS NOT ELIGIBLE.

1. All [state rules](#) and [local rules](#) apply. **MINIMUM AGE IS 16 YEARS.**
2. All amateur and professional work will be accepted regardless of residence.
3. **There are absolutely no refunds of entry fees for any reason.**
4. The Fair reserves the right to order the removal of any exhibit which is not in the best interest of the Fair or which has been entered in violation of its rules and regulations.
5. **SALES:** Art sales will be conducted by an official Fair salesperson. Full payment of sales originating at the Fair must be made before the conclusion of the Fair.
 - a. Artist will be notified when artwork has been sold. Payment to the artist will be mailed after the close of Fair.
 - b. All sold artwork will be held until closing of the Fair at which time it will be relinquished to the buyer. Proper identification will be requested of the buyer. The sold artwork must be picked up during the scheduled Artwork Release Times. (See Schedule of Events on first page of Fine Arts)
 - c. In pricing your artwork, allow 20% of the total sales as a donation to the Fair. The artist will receive 80% of the price listed on the entry form. In addition, the buyer will be required to pay applicable sales tax.
 - d. **PUT THE TITLE AND SALE PRICE ON THE ENTRY FORM.**
 - e. If the artwork is not for sale, write 'Not for Sale' on the entry form.
6. No advertising material of any kind will be allowed in the Fine Arts Department without approval of Supervisor.
7. No artwork may be removed from the Fair prior to the scheduled Artwork Release time at the close of the Fair.
8. American system of judging will be used unless otherwise noted.
9. All works must be the original work of the artists. No precast or pre-made patterns may be used in the Fine Arts Competition. "INDEPENDENT" artwork done in a classroom setting is eligible if it is one-of-a-kind and not produced by the other students in the class. **Work copied from any art publications or from another artist is not eligible to compete.**
10. Each piece of artwork must be marked on the back, top left-hand corner, or on the base, with the artist's name and title of artwork and phone number as it appears on the entry form.
11. Poorly framed and wired art may not be displayed if deemed unsafe.
12. RELEASE: Artist retains all rights; however, the artist agrees that the visual arts entry may be displayed and used for publicity purposes at the sole discretion of the Fair management.
13. GICLEE PRINTS of paintings must be entered in Print Media #307 Class 2. This does not apply to giclees of photographs entered into Photography.
14. **Photographs on METAL and CANVAS** must be entered into the Special Effects categories.

FRAMING AND HANGING RULES:

1. ALL ARTWORK MUST BE SECURELY WIRED FOR HANGING. No non-wired, serrated metal bar hanging devices or raw edged glass will be accepted. Paintings must be dry when delivered. We encourage the use of acrylic instead of glass on larger works due to the weight of glass. Also, please use secure frames firmly fastened together. Watercolors, works on paper, and cartoons may be protected with glass or acrylic. No raw glass edges allowed.
 - a. Fragile Works: At time of entry, works deemed extremely fragile may be disallowed unless properly protected by a case or other suitable means provided by the artist.
 - b. Each visual arts entry must be in its original format.

Section IV

AWARDS

1. Awards offered are per class except as noted per division, sweepstakes, or special awards. Honorable mention ribbons will be given in classes where warranted.
2. Although there is no limit to the number of entries per Visual Artists, there can be no more than two awards paid in each class per person. See Photography dept. rules for number of photographs allowed.
3. It is agreed and understood that all entries/exhibitors may be photographed for publicity and promotional purposes.
4. **THE AMERICAN SYSTEM OF JUDGING** is a competitive system.

Exhibits are placed before a judge or group of judges who rank the exhibits. The exhibits are then awarded prizes based on the quality of the exhibits. A standard of quality is employed here also, but the exhibits are judged against the standard as well as each other. Most often, the best exhibit receives a First Prize ribbon, the next best exhibit a Second Prize, and so forth. However, a judge may determine that there is no exhibit worthy of First Prize and would award the best exhibit a Second Prize, a Third Prize or no prize at all. A judge may not award the same prize to more than one exhibit (i.e. no ties allowed).
5. Awards are offered based on judging by a diverse panel of San Mateo County and San Francisco County professionals.
6. **Judging is based on ORIGINALITY, CRAFTSMANSHIP, CONTENT, AESTHETICS, AND INTENTION.** Artist's names are not visible to judges at any time before or during the judging session.

Special Notes:

This award is given in honor of Lois Kelley, past Board Member, past President of the San Mateo County Event Center and Fair Association, and past manager of the Fine Arts Department.

Eligibility:

No entry or fee is required to be considered for this award. One award is given to the top overall exhibitor in the Visual Arts, one award to the top exhibitor in Photography, and one award in the Literary Arts based upon cumulative awards won. Winners of this award are not eligible to receive it for the following two years.

Honorable Mention Awards are not given the same consideration as 1st, 2nd or 3rd place in the ribbons counts and will be used only at the judges' discretion as numerical tie-breakers for this award.

1. Abstract (cannot contain recognizable imagery)

Please no overt nudes—must be viewable by small children

DIVISION 303 – CARTOONS AND GRAPHIC ART

CLASS:

1. All Cartoon and Graphics including digital art

DIVISION 304 – MIXED MEDIA AND COLLAGE

Any two-dimensional piece using more than one medium on paper, canvas, board or panel
Three Dimensional works must be entered into the Sculpture Division #308

CLASS:

1. Mixed Media and Collage

DIVISION 305 -- FINE ART GLASS

Includes two or three-dimensional cased, cast, etched, sand carved, blown, stained glass, etc.

CLASS:

1. Hot Glass - includes blown glass, solid-sculpted glass and cast glass
2. Warm Glass – slumped, kiln glass, kiln-casted glass, bent glass, flame-worked glass, pate de verre
3. Cold Glass - sandblasted, acid etched, grinding, polishing, engraving, assembled and glued

DIVISION 306 – CERAMICS AND POTTERY

CLASS:

1. All Pottery and ceramics

DIVISION 307 – PRINT MEDIA

Includes traditional etchings, lithographs, serigraphs, woodcuts, linocuts, etc. that utilizes transferred imaging.

CLASS:

1. Traditional Print Media
2. Digital reproductions of original art (giclees) on either canvas or paper (giclees of photographs not accepted)

DIVISION 308 – SCULPTURE

CLASS:

1. All 3-D traditional materials (clay, stone, wood, etc) Non-traditional materials may also be entered in this division. If artwork is made from at least 50% recycled materials, you may want to submit into the Found Art Division, especially if it has a “recycled” flavor to it.

DIVISION 309 – JEWELRY

SPECIAL NOTES: NO SETS--Please submit each item individually. For example: if you have matching earrings and necklace that would be two submissions; one for the earrings and one for the necklace. If sets are submitted, they will be disqualified.

Leave entries open for touching and examining (don't pin down or encase) It is easier to examine a piece that is not locked down so that the workmanship is evident.

**The judge would like to have the title of the piece and a short description of what was the inspiration for the piece and any other brief information that you would like to include

CLASS:

1. Lampwork or fused glass – This category includes beads, buttons, components or jewelry-related objects that are at least 85% or more glass made by the applicant. Entries that use someone else's glass beads or components should be entered in “Finished Jewelry” Class 10.
2. Metal Clay – This category includes all beads, buttons, components, jewelry or jewelry-related objects that are at least 85% or more metal clay made by the applicant. Entries that use someone else's metal beads or components should be entered in “Finished Jewelry” Class 10.
3. Seed Beads – This category includes beaded beads or a piece of jewelry that is at least 85% or more seed beads/bugle beads and that uses weaving as the primary technique.
4. Wirework – This category includes all jewelry, accessories, handmade beads, jewelry-related objects and sculptural objects that are made predominately with wire or in which the primary techniques used are wirework techniques.
5. Chain Maille – This category includes all jewelry, accessories, jewelry-related objects and sculptural objects in which at least 85% of the primary technique used by the applicant is chain maille.
6. Polymer Clay – This category includes beads, buttons, components or jewelry-related objects that are at least 85% or more polymer clay made by the applicant. Entries that use someone else's polymer beads or components should be entered in “Finished Jewelry” Class 10.
7. Fabricated or Cast metal – This category includes all jewelry or jewelry-related objects that are fabricated and/or cast entirely by the applicant. **All synthetic and natural stones are accepted in this category.**
8. Strung Jewelry -- This category will include a piece of jewelry that is made from materials such as, but not limited to, glass beads, crystals, semi-precious stones, wire, metal clay, seed beads (piece must be less than 40 percent seed beads), found objects, etc. NOTE: If the piece predominantly showcases another category (such as polymer clay), it should be submitted into that category.
9. Beaded Objects or Accessories -- This category includes a non-jewelry item or accessory, including, but not limited to, purses, shoes, sculptures, or wall hangings

DIVISION 310 – SAN MATEO COUNTY SCENES

Sponsored by Leona Moriarty, SWA

Special Notes: This award is given to the artist whose painting is judged the best representation of a scene from anywhere in the county of San Mateo. Subject matter includes either natural or urban scenes and the **work must contain a reasonably recognizable landmark in order to qualify.** Maximum number allowed is two entries in this division. Work must have been painted within the last three years and not previously shown at the SM County Fair.

Eligibility: This contest must be entered on the entry form.

NEW RULE -- Entry may not be entered into another contest

CLASS:

1. San Mateo County Scenes

DIVISION 311 - "CARRY THE LIGHT"

Sponsored by the Peninsula Art Museum

Special Notes: This prize is awarded to the one artist whose work best represents the theme of "CARRY the LIGHT" in either the **Visual Arts (2-D and 3-D) or Photography divisions.** This is completely open to the artist's interpretation, which may be literal, symbolic or suggestive of the theme. Maximum number allowed is two entries in this division.

Eligibility: This contest must be entered on the entry form.

NEW RULE -- Entry may not be entered into another contest and duplicate photo prints may not be submitted to other contests.

CLASS:

1. "Carry The Light"

DIVISION 312 – DIA DE LOS MUERTOS/DAY OF THE DEAD

Sponsored by Peninsula Artist Eva Portillo

Eligibility: This contest must be entered on the entry form. Entering the same piece into another division is not allowed. 2 and 3-dimensional art welcome. Not open to Video entries. Open to all Visual Art, Photography and Craft Specialties. Only one 1st, 2nd, or 3rd place awards offered for all classes combined. Only first place receives a premium award.

CLASS:

1. Any two-dimensional art or photo---must be framed and wired properly (see Visual Arts General Rules)
2. Sculptures
3. Any craft specialties including masks, sugar skulls, candles, mini boxes, tote bags, aprons, sewn dolls, quilts, pillows, paper mache skeletons or skulls, tissue flowers Papel Picado (hand cut paper).



DIVISION 313 – FOUND ART & ASSEMBLAGE ART

SPECIAL NOTES: Art must be composed of at least 50% recycled or discarded items. Kinetic art is welcomed. May be floor-standing, hanging wall art, or pedestal art (we have pedestals).

Wall pieces (like shadow boxes) must be wired for hanging. Max weight for hanging art is 15 lbs. Explanation of materials used may accompany each item on a 3x5 white index card using 12 point Helvetica. **Mixed Media Dolls and Altered Books** are eligible in this division as well if they meet with the recycled requirements. No kit or classroom work is eligible to enter. Judges are looking for the unique use of discarded items.

CLASS:

1. All entries, whether 3-D or 2-D.



Section IX PENINSULA MUSEUM of ART

DIVISION 314 – BAY AREA MASTERS

Sponsored by the Peninsula Museum of Art

This is a juried exhibit by the Peninsula Museum of Art and is open to professional artists living within the nine counties of the San Francisco Bay Area. Unlike other art contest, the **entry fee is \$25 per entry. Use the general entry form in the contest book or enter online.**

Award: Best of Show Ribbons for 2-D and 3-D winners. Solo exhibitions to be selected by the Peninsula Museum of Art's Curatorial Committee and scheduled at the Peninsula Museum of Art.

RULES:

1. **Submit entry forms and checks** directly to www.sanmateocountyfair.com using the online registration. Artists may **submit up to 3 entries**. Entry fee is \$25 per entry. All entries must use the official county fair entry form. **ENTRY DEADLINE IS APRIL 16 FOR THIS JURIED EXHIBITION.** Late entries will not be considered. Do not send any jpegs with entry form.
2. **Email jpeg(s) of your entries by April 16** to peninsulamuseum@gmail.com with Bay Area Masters in the subject line. Include one jpeg of each 2-D work or two views of each 3-D work. The email must include the applicant's name, phone number, and email address. Titles must match up with county fair entry form titles, Attach all entries in jpeg form (no larger than 2MB) and list entries by title:
 - Example #1: "Waterfall", 12 h x 36 w, mixed media (or painting, print, etc.)
 - Example #2: "Warlock", 48 x 12 x 10, steel (or wood, ceramic, mixed media, etc.)
3. The ENTRY FORM is available online at www.sanmateocountyfair.com and also in the printed version of the contest book in many Peninsula Libraries.
4. Accepted artwork for Bay Area Masters must be delivered to the Fine Arts Galleria in Expo Hall on **Thursday, June 6, between 12 noon and 6 p.m.**
5. **This is a juried exhibition. No refunds are given for entries not accepted.**

Section X

PHOTOGRAPHY CONTESTS

AWARDS OFFERED

DIVISION 315 (in each class)

1 st Place	\$50	Rosette

RULES: *Please read carefully – rules do change (new rules #2 and #3)*

1. **FORMAT:** Each photo must be in its original format (except Special Effects Classes 27 & 28) and taken within the last three years. No raw glass edges allowed. All images must be framed.
FRAME SIZE must be NO LARGER than 28 inches (inside dimension) on the long side (size limit is 14 inches for the cell phone-camera competition). **Metal Prints may not exceed 28” on the long side.**

Photojournalism Photo Essay images should be mounted in a single frame.

FRAMES MUST BE SECURELY WIRED FOR HANGING (THAT INCLUDES PRINTS ON METAL). Serrated or other hanging devices will not be accepted. This rule is strictly enforced during drop-off.



2. **Prints on canvas and prints on metal medium must be entered into the Special Effects classes.** Metal prints must be wired securely for hanging.
3. **LIMIT ON ENTRIES** -- This is a non-juried competition. All entries will be hung in the exhibit. With that in mind, contestants will be **limited to 15 entries** across all photography classes combined.
4. We discourage the use of glass and will not be responsible for any breakage and resulting damage to images – it happens. We also strongly encourage the use of non-glare acrylic due to strong overhead lighting reflecting on glass.
5. Photos entered into the wrong classes will be re-assigned without notice to the artist.
6. **JUDGING:** Photography will be judged on originality, craftsmanship, content, aesthetics, and intention. Judges reserve the right to not make awards if they feel there is nothing entered of merit.
7. **RELEASE:** Photographer retains all rights; however, the photographer agrees that the photo may be displayed and used for publicity purposes at the sole discretion of the Fair management.
8. **RETURN:** Photography must be picked up on Artwork Release Monday immediately following the end of the Fair (see Schedule of Events at beginning of art section). The San Mateo County Fair assumes no responsibility for photos not picked up on the designated pickup day.
9. This is a family oriented competition and exhibit. Children will be viewing this exhibit. With that in mind, photography must not, in the sole and unfettered discretion of the competition staff, contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content.
10. In Color and Black & White Classes, photos utilizing digital filters, digital color enhancement, and special effects of any kind, infrared film, non-traditional development techniques, High Dynamic Range (HDR), prints on canvas or metal medium, and digitally stitched panoramas must be entered into the Special Effects Classes, 27 and 28. Digital processing that utilizes techniques and practices that were employed in a traditional darkroom are acceptable. Photo Judges reserve the right to reclassify any work they feel has been enhanced beyond acceptable processing practices.
11. There are absolutely no refunds of entry fees for any reason.

DIVISION 315 – PHOTOGRAPHY

(Please note that there is a limit of 15 entries per contestant across all classes)

ABSTRACT means no recognizable images. **SURREAL** is characterized by recognizable yet fantastical imagery and incongruous juxtapositions.

STREET PHOTOGRAPHY: Street photography is fine art photography that features the human condition within public places. Framing and timing are key aspects of the craft, with the aim of creating images at a decisive or poignant moment. Street photographers create fine art photography (including street portraits) by capturing people in public places, often with a focus on emotions displayed by people in public.

METAL PRINTS and CANVAS PRINTS are considered a non-traditional special effect enhancement and should be entered under Class 27 or 28. All prints on metal require a strong hanging wire on back. No other types of hangers are allowed.

Special Category Classes:

25. **Photojournalism --The single image** class is a photo that fully captures the story of an event with a single image. Photojournalism shows us things that we would not normally see and takes us places we would not ordinarily go. Henri Cartier-Bresson called it the "critical moment."

27. **Special Effects -- Computer generated** (including GICLEE prints of photographs). Computer generated is the creation of images in a digital image editing program. These can include collages or other creations that an artist conceives. **METAL PRINTS and CANVAS PRINTS are considered special effect enhancements.**

29. **Cell Phone Photography** -- Photos, color or black & white, taken with a cell phone camera only. This class takes into account that a number of people use their cell phone camera to take creative photographs. The photos should be framed as other Classes with the exception that frames must be **NO LONGER THAN 14 inches (inside dimension) on the long edge. Images entered in this Class cannot be entered simultaneously in another photography class.** If applying any special effects the images must be entered into the Special Effects Classes

26. **Photojournalism -- The photo essay** class is 3 to 5 photos of an event that **tells a story** on a single theme so that they give a deeper, fuller, more rounded view of the subject than a single image can. The organization can be either chronological or thematic but the photos should work together to enrich the theme. **All of the images should be mounted in a single frame.**

28. **Special Effects -- Photographic** -- Photographic would include adding special effect to a photo such as blurring, zooming, use of infrared film or digital sensor, special filters, HDR, etc., while taking or processing the photo. **METAL PRINTS and CANVAS PRINTS are considered special effect enhancements.**
