REQUIREMENTS, BENEFITS AND RESPONSIBILITIES**

The San Mateo County Fair Board will be made up of and not to exceed 20 total members representing the youth of San Mateo, San Francisco and Santa Clara Counties. Applications must be received at the Fair Administration Office by July 31st, 2018. There will be no exceptions for late applications. An interview process will follow for potential candidates at a date and time to be announced individually.

REQUIREMENTS

- San Mateo or San Francisco County resident
- Enrolled in high school or equivalent program (18 or younger)
- 2.0 GPA during immediate past semester
- Willingness to meet all responsibilities listed below
- Attend monthly meetings on the third Thursday at 7pm

RESPONSIBILITIES

- Mandatory attendance at a minimum of 1 regular meeting of the Fair Oversight Committee. Meetings are held on the First Thursday of each month at 4pm.
- Attendance and active participation at least 80% of Junior Fair Board activities including fair promotion, community improvement activities and meetings. Two or more unexcused absences may result in termination from the Junior Fair Board.
- Actively involved in at least one special programs within the fair (could involve livestock or any department, special promotion days, award announcements, sponsor interaction, etc.). This requires a minimum of 10 hours participation during the fair.

BENEFITS

- Fair apparel and giveaways as determined by fair management
- Daily fair admission for board member and 4 complimentary admission tickets for guests/family
- 1 day carnival wristband
- Letter of recommendation for college and/or related awards
