Please read all information carefully. Attached is the required form for Independent Exhibitors. (This is NOT your official entry form. This is due in *addition* to you Livestock & Small Animal Online Entry & ALL required livestock documents)

Independent youth exhibitors must be at least 9 years old or in 4th grade by January 1, 2024. Exhibitors are eligible to compete/exhibit through December 31 of the year in which they turn 18 years of age and/or the same calendar year you have completed high school. Independent exhibitors MUST be a full-time resident of San Mateo/San Francisco County. Independent exhibitors must be chaperoned by a parent or legal guardian at all times while on the fair grounds. The legal guardian must be 21 years of age or older and have been listed on the Intent to Exhibit form which was filled out at time of entry.

Complete the attached form and return it to the Fair's Entry Office, with photographs of you and your animal no later than 5:00pm April 2, 2024.

**2024 San Mateo County Fair Independent Exhibitor deadlines for submitting Declaration of Intent to Exhibit Livestock are as follows:**

<u>Beef:</u>	Tuesday, April 2, 2024
<u>Sheep, Swine, Goats:</u>	Tuesday, April 2, 2024
<u>Rabbits, Turkeys, Chickens &amp; Meat Birds**:</u>	Tuesday, April 2, 2024

Independent junior exhibitors entering market and breeding animals must provide the fair management with

- 2 pictures of the animal (a close up side view with exhibitor and a front view of animal)\*\*
- Appropriate proof of ownership (Bill of Sale)
- Permanent tag and/or tattoo information by ownership deadline as outlined in State Rules
- Declaration of Intent to Exhibit signed by your parent/guardian stating who will be supervising the exhibitor at all times
- **Animals entered by Independent Exhibitors must be OWNED and IN POSSESSION of the exhibitor for the required time period per species as stated in the contest book**
- Independent Exhibitors must purchase insurance coverage as required by Fair
- Read Livestock Rules for appropriate dress code and all Independent/Exhibitor rules
